CHILDREN AND YOUTH WORKER JOB DESCRIPTION

TITLE

Children and Youth Worker

PLACE OF WORK

The Parish of St Peter's and St James (SPSJ), Hereford

HOURS

20 hours a week to be worked flexibly including evening and weekend work, to include at least 3 full days off per week.

HOLIDAY

Full time entitlement is 6 weeks, including 6 Sundays (pro-rata). The post holder is expected to work on Good Friday, Easter Sunday, and Christmas Day.

SALARY

£10,400

All employees on this project will be enrolled onto the Hereford Diocese Payroll and will automatically join the Diocesan pension scheme.

CONTRACT LENGTH

A Fixed term contract to October 2025, inc. a 3-month probationary period.

AIM OF THE POST

The relationship with our two primary schools has grown enormously in recent years and we are now starting to see growth in our Children and Youth Groups. We are looking for someone with a passion of reaching younger generations to join our growing team to help the continued growth of this vital ministry.

To play an active role in the Children and Youth Work within the parish:


- Children's Church (provision for 3-16yr olds during Sunday morning worship)

- Messy Church (monthly Monday after school in St James Church)
- St James Primary School (leading Collective Worship, facilitating Prayer Spaces, helping with Experience Easter/Harvest/Christmas services)
- St Thomas Cantilupe Primary School (leading Collective Worship, facilitating Play Ground Interaction)
- Working alongside SPSJ team in educational chaplaincy at Bishop of Hereford Bluecoat's School (secondary) and local colleges (Sixth Form and others)
- Partnering alongside youth workers at Close House (a detached youth work charity based in the centre of Hereford).
- Involvement in the emerging city-wide ecumenical youth work (previously starting before Covid pandemic)
- Involvement in our Online Ministry as appropriate
- Annual Bible Holiday Club (during school holiday)
- Assist the Staff Team in setting up for bigger events

NOTES

Given the nature of the role and the importance of its place in promoting and communicating the aims of the St Peters and St James and within the provisions of the Equality Act 2010 there is an Occupational Requirement that the post holder be a committed Christian.

Given the nature of the role an enhanced DBS check is required.
